Principal's Report:

- The students were grateful for their Year 12 gift packs. The cupcakes were a good idea because they reduced mess, lessened COVID contact and there was no queue while a larger cake was cut.
- Enrolments encouraged from Year 5 students in the catchment area. To ensure ABHS is front of mind when school selection occurs in Term 1 of 2023. Immersion days were held for Arts and Science (10 more than expected for Science). Next year it will be considered to also include TAS and PE.
 St. Ives will have their numbers capped due to capacity
 Maybe more co-operative events can be done with Asquith Girls High to capture the interest of parents who want a co-educational school.
- Matt Kean has replied to request for funding of Multi-Purpose Centre (MPC). The response mentioned competition for funding and quoted amounts spent, over years, in Asquith High Schools.
 The issue will be pressed again the need for an MPC citing the necessity of physical development for boys, advantages to the community, climate change
- Plant Bug plants have arrived but will not be planted because of water issues.
- 60th Anniversary book storage is becoming and issue. The strong room is full and other areas my be prone to mold.
- There may be room to better align course streams with universities prerequisites.
 - Students are encouraged to do the subjects they like, to obtain better results.
- The question of transport costs have been disrupted by the shortage of buses.
- One student was left behind at sports raising the question; who is responsible for students' safety and until what time?
- High School Experience Day was very successful. Students were excited and parents got to see their kids
 in a high school classroom.
- School Values team have selected banners representing the values of Respect, Responsibility and Excellence. Banners will be situated at entrance and throughout the school. Winners will be announced in Backchat.
 - How the values translate into the school
 - Merit and Leadership passport to measure positive incidents (e.g. towards being a Prefect) and acknowledgement during school assemblies.
- Hawkesbury River painting by indigenous students will be located in front office.
